#### 1. Categories of Pupil Information We Process

- Personal identifiers and contacts (e.g. name, address, contact details)
- Characteristics (e.g. ethnicity, language, free school meal eligibility)
- • Safeguarding information (e.g. court orders, professional involvement)
- Special educational needs (including the needs and ranking)
- Medical and administration (e.g. allergies, medication, health data)
- Attendance (e.g. sessions attended, absences and reasons)
- Assessment and attainment (e.g. Early Learning Goals)
- Behavioural information (e.g. exclusions, interventions)

### 2. Why We Collect and Use Pupil Information

- To support pupil learning
- To monitor and report on pupil progress
- To provide appropriate pastoral care
- To assess the quality of our services
- To keep children safe (e.g. allergies, emergency contacts)
- To meet statutory duties from the Department for Education (DfE)
